


Teleconferencing and Public Hearing Protocol


hearing teleconferences Public electronic extensions of the committee process, and are usually limited to a specific subject or bill. The chair may request that the testimony be limited to a certain length of time, and will decide the participation order of in the teleconference. Before beginning your testimony, state your name and who you represent, if applicable. Remember to identify yourself each time you speak. Indicate to the chair when you have concluded your testimony. Hearing protocol is selected by the committee chairperson. Teleconference protocol during formal committee meetings shall be designed to serve the agenda of the committee and accommodate conventions of a legislative hearing.

Facilitating Communication Between You & Your Legislators:

Legislative Information Offices and their staff are the first stop for constituent information and inclusion in the governmental process for all Alaskans. The LIO participates in outreach programs such as Legislators in Schools which allow us to enter classrooms of young children to let them know who represents their interests in education and other aspects of government. The staff is invaluable as the first line contact with Alaskans for a multitude of questions and issues which arise. The LIO assists with making the governmental process within fingertips reach for all Alaskans, young and old.


